In the name of the State of Maine, you are hereby required by law to notify and warn the inhabitants of the Town of Beddington qualified to vote in town affairs, to meet at the Community Building, April 1, 2023, at 9:00 am in the morning for the following purposes to wit:

ARTICLE 1

To choose a Moderator to preside over said meeting, and to be paid \$25.

ARTICLE 2

To nominate and elect all necessary Town Officers for the ensuing year. For the election of such Officers, the polls will open immediately after the election of the Moderator and will close immediately after such Officers have been elected at which time the meeting will be resumed to act on the remaining articles.

ARTICLE 3

To see what sum of money the town will vote to raise or appropriate for the salaries of the Town Officers, and others as listed, and to fix their salaries. (Recommend to raise \$46,000.00, which includes 8% for Town's portion of payroll taxes.)

ARTICLE 4

To see if the Town will vote to change Headwaters Limited Residential from 10 acres to 5 acres for a building lot size as described in the Land Use Plan and Shoreland Zoning Ordinance.

ARTICLE 4A

To see if the Town will vote to add an Ordinance to the Land Use Plan and Shoreland Zoning Ordinance regarding individual lots being subdivided (see handout).

ARTICLE 4B

To see if the Town will vote for the Planning Board to establish a schedule of fines for violations of the Land Use Plan and Shoreland Zoning Ordinance.

ARTICLE 4C

To see if the Town will vote to approve replacing the overhead garage doors on the Firehouse. The cost will be \$10,000.00 or less. Funding will come from the General Fund Surplus and the money will be replaced from the sale of a Town owned property.

ARTICLE 4D

ARTICLE 4E

To see if the Town will vote to approve putting Cynthia Gay as the signature on the G. Stickney Trust and the Ministerial School account.

ARTICLE 4F

To see if the Town will vote to approve moving the G. Stickney Trust and the Ministerial School account to the regular Town account. Current bank doesn't wish to keep these accounts. These accounts would be monitored for interest that could be used at the Cemetery (Stickney Trust) and put into the School scholarship (Ministerial School Account).

ARTICLE 5

To see if the Town will vote to authorize the Selectmen to appropriate from undesignated fund balance a sum not to exceed \$3,000.00 as they deem advisable to meet unanticipated expenses and emergencies that occur during the fiscal year 2023. (Recommend \$3,000)

ARTICLE 6

To see if the town will authorize the Selectmen, to dispose of tax acquired property in any manner which the Selectmen deems to be in the best interests of the Town. Except that the Municipal Officers shall use the special sale process required by 36 M.R.S. section 943-c for qualifying homestead property if they choose to sell it to anyone other than the former owner(s).

- (A) A notice of intent to sell such property shall be published in a newspaper of general circulation in Washington County at least three weeks prior to such sale, inviting interested parties to submit sealed bids thereon. _Q
- (B) The parties from whom the property has been taken for non-

payment of taxes thereon may purchase said real estate from the Town at any time before the expiration of fourteen days from the date of such publication, plus interest, lien costs, and the cost of publication of the notice plus the cost of the quitclaim deed.

(C) In the event the parties from whom the real estate was taken by the Town for the unpaid taxes fail to redeem the property, the Board of Selectmen reserve the right to accept or reject any and all bids.

ARTICLE 7

To see if the Town will vote to authorize the Board of Selectmen to accept, on behalf of the town, unconditional gifts of property and/or donations which they feel are in the town's best interest to accept.

ARTICLE 8

To see what sum of money the town will vote to raise or appropriate for Administration. (Recommend to raise \$31,000 and appropriate \$7,000 from general fund surplus.)

ARTICLE 9

To see if the Town will vote to authorize the Selectmen to spend up to 25% of the 2023 budget in fiscal year 2024 prior to the Town Meeting. (Recommended)

ARTICLE 10

To see if the Town will vote to allow the Selectmen/Treasurer to use Surplus Funds during the fiscal year in anticipation of Property Tax Receipts. (Recommended)

Explanation: The additional local funds are those locally raised funds over and above the Town's local contribution to the total cost of funding public education from Pre-K to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the municipal budget for educational programs.
